## **Subscription contract on full online access to the Organ Site**

– in the following referred to as "The Organ Site" –

and

– in the following referred to as "client" –

agree on the following subscription contract:

### **1. Subject matter of the contract**

1.1. Subject matter of this contract is the granting of full online access to the information on organs offered on the Organ Site, against payment of a first-time subscription fee of EUR 29.- incl. VAT / tax for a one-year subscription or a renewal fee of EUR 15.- for any subsequent renewals of the subscription (cf. section.6).

1.2. The contract includes full access to

- all general organ information (history, function, oddities and World records, CD recomm., ...)
- the entire organ database with currently some 5,000 organ stoplists in HTML and Excel format
- some 15,000 organ and church pictures at 8-30 megapixels resolution (personal license – not for commercial use)
- some 4,000 organ pictures at medium resolution (personal license - not for commercial use)
- more than 2,800 additional www links directly to the particular organs / churches / sources
- address data and Google Maps direct links to the denoted churches / concert halls.

All files are unprotected and open to processing.

### **2. The music download is not subject matter to this contract**

This contract explicitly does not cover our separate offer to download music files from several music publishers and obtain a license directly from the publisher. If the client wishes to play those pieces of music he or she will have to make a separate contract with the publishing house. The Organ Site can assist in this.

### **3. Contract implementation**

In accepting the terms and conditions of this contract, the client offers to enter into a subscription contract. The receipt of a confirmatory email indicates that the Organ Site has accepted the offer. After the Organ Site has received the payment of the price agreed upon (for handling of payment cf. section 5. handling of payment) the client will be sent his or her personal user data for login. Transmission will be exclusively via email to the email address given on the order form. From this point on the login will be activated to provide full access to the Organ Site, in particular the retrieval of all organ stoplists and pictures.

User login data are for personal use only. The client undertakes not to pass on these data to any third party.

The subject matter of this contract includes future updates of content which the Organ Site is fully entitled to upload at any time. Music files of the download portal for organ music on this web site are subject to separate payment and are not covered by the present contract (cf. section 2.).

### **4. Right of cancellation**

The client is entitled to cancel this contract within two weeks by written notice (letter or email) without reason. The cancellation period shall commence at the earliest on the day following the receipt of this instruction on the right of cancellation. The deadline for cancellation shall be observed if the notice of cancellation has been mailed in time.

In case of an effective cancellation, mutually rendered services will be refunded and any capitalized use (e.g. interest) is to be returned. The right of cancellation will be terminated early if your contract partner has, with your explicit consent, started implementing his services before the end of the cancellation period, or if you have yourself disposed the implementation (e.g. by download).

## **5. Handling of payments**

Payment can be made in two different ways, entailing different lengths of processing time. If payment is made by PayPal, clicking on the "pay now" button will automatically open a new window using a secure internet connection asking for all relevant payment data.

### **5.1. Payment by PayPal:**

If the sum can be debited to PayPal directly or to another credit card account linked to PayPal the Organ Site will confirm the payment immediately and create a login. In any other case PayPal will send a confirmatory email and debit the sum to the client's bank account. This may take a few days. As soon as payment has been credited to the Organ Site's PayPal account, the latter will create the client's access by hand and send the invoice by email. Handling time varies, depending on payment crediting by PayPal, between "instantly" and "several days".

### **5.2. Payment by bank transfer after receipt of an invoice:**

If the client prefers bank transfer his completing of the order will be followed by a confirmatory email including an invoice. Payment is to be made to the account indicated on the invoice. Once the payment has been credited to the Organ Site's account, the site will manually set up the client's access. Processing time may take several days depending on how long the bank takes to transfer the money. The costs for the bank transfer are to be paid by the client. The client should note that all expenses resulting from a foreign bank transfer would have to be paid by him.

## **6. Duration of contract and price**

The price agreed upon includes full access to the web site [www.die-orgelseite.de](http://www.die-orgelseite.de) for the period of one year. This subscription will NOT renew automatically. The client may renew his subscription at a reduced price of EUR 15.-, using the order form [www.die-orgelseite.de/bestellformular\\_verlaengerung\\_e.htm](http://www.die-orgelseite.de/bestellformular_verlaengerung_e.htm). The price shall be EUR 15.- for a renewal, regardless of whether this renewal is ordered immediately upon expiry of the first subscription or at a later date. In case of a renewal at a later date the subscription shall be valid for one year from the day on which the renewal has been requested.

Towards the end of the subscription period the client will receive an email notifying him of the upcoming expiry and providing him with a link to the order form for subscription renewals.

## **7. Right to extraordinary cancellation**

Both parties reserve the right of extraordinary cancellation without prior notice in case of an infringement of single contractual provisions, or due to important reasons, or to refuse the registration of any particular person. In case of an effective extraordinary cancellation the Organ Site shall not be held liable to reimburse the price agreed upon. A right to extraordinary cancellation may especially result from

- 7.1. the client having given incorrect personal data,
- 7.2. the probable cause that the user data that have been supplied for personal use have been passed on by the client to a third party,
- 7.3. the client, with effect to the future, revoking his consent to the storage and use of his personal information or
- 7.4. a misuse being suspected that would let the continuation of the contract be deemed unreasonable.

## **8. Liabilities**

The provider of the Organ Site cannot be held liable for damages caused by a breach of duty on the side of the client which could have been prevented if duties had been properly observed. The client will be held liable for any damages to the rights of a third party to the latter as well as directly. In cases of justified claims of a third party against the client due to a breach of duty on the client's side, the latter is bound to indemnify the Organ Site unless he can prove that he cannot be made responsible for the breach of duty leading to the damage.

## **9. Privacy**

In order to install a personal user access some personal information is required which indicates the client's identity, such as name, email address, postal address, etc. This information will only be collected, saved and processed for the purpose of implementing and handling the contract. All data will be treated strictly confidential. The Organ Site will at any time observe all privacy regulations.

The Organ Site and its subpages run on a secure SSL encrypted internet area (HTTPS).

The Organ Site does **not** send out email sales messages or spam and it does not cooperate with any address broker. The Organ Site does **not** use any cookies, trackers, analytic tools (i.e. Google Analytics) or ads (data collection by online advertising providers).

Subscribers with full access to the Organ Site agree to receive a reminder email with the offer of a subscription renewal one month before the subscription period ends, as well as an informational email after the subscription has ended with a link to the possibility of renewing the subscription.

When paying by PayPal relevant transaction data will be forwarded to PayPal to be able to process the transaction. After forwarding to PayPal the privacy policy and terms of PayPal apply. For CD orders, the order data with your name and address will be forwarded by encrypted email to the delivering publisher, so that he is able to process the order.

Every login to the Organ Site is internally logged with the entered user name as well as the IP address and the name of the internet provider from which the access is made. This data is used to uniquely identify the person who logs in and to ensure correct access to the Organ Site. The log data will not be passed on to third parties.

The customer may, at any time, with effect to the future, revoke his consent to the use of his data. He can do so by sending an email message to [cancel@die-orgelseite.de](mailto:cancel@die-orgelseite.de). For unambiguous identification please give your name and surname as well as your user data. If the consent to the use of the data is revoked the former login will be deleted so that the customer will no longer be able to access the subscribers' section.

These privacy provisions can be accessed and printed out from the imprint section of [www.die-orgelseite.de](http://www.die-orgelseite.de) at any time before or after concluding the contract.

## **10. Complaints**

## **11. Offsetting**

The client only has a right to offset if legal judgment has been passed on his claims or if the Organ Site has not challenged them. Furthermore, the client is only entitled to exercise his right of retention insofar as his counter-claim results from the same contractual relationship.

## **12. Applicable law**

The applicable law shall be the law of the Federal Republic of Germany, excluding UN Sales Law, as well as the Conflict Rules of Private International Law.
